### CUYAHOGA COUNTY SHERIFF'S DEPARTMENT – (216) 443-6084

If the Cuyahoga County Sheriff's Department impounded your vehicle, it will be located at 3929 Superior Avenue in Cleveland. You do not need to go to the Sheriff's Department to obtain a release. You will need to call United Towing to make sure the Sheriff's Department has approved the release of your vehicle. If so, you must bring a valid driver's license with a matching title for the vehicle. There is no charge to obtain the release for the vehicle, but you will be charged for the towing, storage, and any additional labor for your car. The Sheriff's Department issues releases for vehicles Monday through Friday 8:00AM-4:00PM. Generally they do not release vehicles on weekends or holidays. Please verify with United Towing that there are no other special requirements to retrieve your vehicle.

### **EUCLID POLICE DEPARTMENT – (216) 731-1234**

If the Euclid P.D. impounded your vehicle, it will be located at 21200 St. Clair Avenue in Euclid. You will need to obtain a vehicle release from Euclid P.D. at a cost of 20 dollars. The Euclid P.D. tow release must be presented at 21200 St. Clair Ave and all towing and storage costs must be paid in order to remove your vehicle. ### **SOUTH EUCLID POLICE DEPARTMENT – (216) 381-1234**
